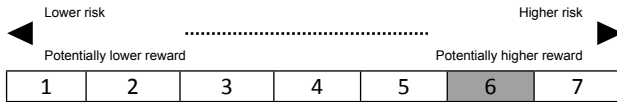

### Objectives and investment policy

The fund is actively managed. The fund is not managed in reference to a benchmark. The objective of the investment policy is to achieve long term capital appreciation. In order to achieve this the fund invests globally in equities of international issuers. When selecting investments, environmental and social aspects and the principles of good corporate governance (ESG aspects) are taken into consideration alongside the financial performance.

Furthermore, in the portfolio construction the fund management is focusing on constructing an equity portfolio that is expected to have a lower carbon intensity in comparison to the broad equity market. The currency of the fund is EUR. Returns and gains are not distributed but are reinvested in the fund. You may request the redemption of shares generally on a daily basis.

### Risk and reward profile
