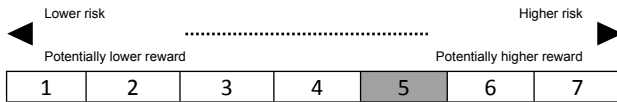

Objectives and investment policy

The fund is actively managed. The fund is not managed in reference to a benchmark. The objective of the investment policy is to achieve a medium to long-term sustainable capital appreciation. In order to achieve this, the fund invests mainly in equities of domestic and foreign issuers from which an above-average dividend yield is expected. A major criterion when selecting the

equities is the level of the dividend yield. However, the dividend yields do not necessarily have to be above the market average. The selection of individual investments is at the discretion of the fund management. The currency of the fund is EUR. The fund distributes quarterly. You may request the redemption of shares generally on a daily basis.

Risk and reward profile



The calculation of the risk and reward profile is based on historical data that cannot be used as a reliable indicator for the future risk profile. This risk indicator is subject to changes; the classification of the fund may change over time and cannot be guaranteed. Even a fund that is classified in the lowest category (category 1) does not represent a completely risk-free investment. The fund is classified

in category 5 because its share price fluctuates comparatively strongly and the likelihood of both losses and gains is therefore relatively high. The following risks could be of particular significance for the fund: The fund invests in equities. Equities are subject to strong price fluctuations and thus also to the risk of price decreases. The seeks to generate income from dividends, i.e. from expected distributions per equity. If a company distributes a smaller dividend than expected or no dividend at all, this can have a negative impact on the value of equities or derivatives. 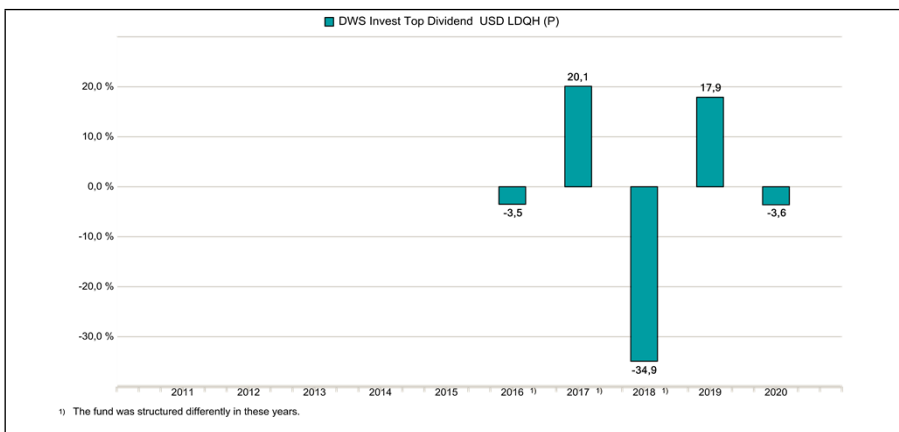
Charges
