Performance Review

In March, the stock markets had a flood of news to digest and ended the month in the red. The new US administration made headlines almost daily, unsettling the markets. This is illustrated by the continued rise of the crisis currency gold. For example, the White House announced tariffs on imports from Mexico and Canada, only to suspend them hours later, and weeks later announced tariffs of 25% on all car imports. The erratic US policy also seems to unsettle US consumers, as seen in consumer confidence data and business outlooks of some companies. The approach to achieving a ceasefire in Ukraine shows that European states must face the new reality. The adoption of a military and infrastructure package worth hundreds of billions in Germany is a direct consequence of this. This led to better relative performance of European stocks in general and defense stocks in particular, and rising interest rates on bonds of European states, even though the ECB lowered the key interest rate to 2.5%. The S&P 500 Index fell by 5.6%, while the growth-oriented NASDAQ Index lost 8.1% (both in US dollars). In Europe, the MSCI Europe fell by 3.9%, while the DAX recorded a minus of 1.7% (both in euros). The euro appreciated by about 4% against the US dollar over the course of the month. In Japan, the Nikkei 225 fell by 3.4% (in yen), and the yen also depreciated by about 4% against the euro. Stocks in emerging markets, on the other hand, ended the month with a slight plus of 0.6% (in US dollars), supported by gains in China. With the exception of energy, all sectors ended the month with losses. Defensive sectors such as utilities, healthcare, and consumer staples performed relatively better. The biggest losers, as in the previous month, were consumer discretionary, communication services, and IT.

Performance Attribution

DWS Invest SDG Global Equities fell by 6.72% in March. The MSCI World all country (total return, in euros) was down 7.59% over the same period. Part of this difference can be explained by the different valuation dates at the beginning of the month.

The relative performance of the fund was positively influenced by allocation and selection effects in the reporting month. The overall selection within the sectors had a positive contribution in March, especially in the Financials, Utilities, Communication Services, and Consumer Discretionary sectors. Selection within the Industrials, Consumer Staples, and Technology were detrimental to performance during the reporting period.

Sector allocation in March had a positive contribution to fund performance. The underweight in Consumer Discretionary and Technology and overweight in Health Care, Industrials, and Utilities contributed positively to performance, while the underweight in Financials and Energy was detrimental during the month.

Current Positioning

We did not make any significant changes to the portfolio in March. Among other things, we exited our position in a renewable energy company operating a portfolio of biomass, hydro-electric and pumped hydro storage generation assets. The company potentially contributes to UN Sustainable Development Goal 13 "Climate Action". Available funds were partly used to build a position in a US company offering foreign language courses through a mobile learning platform. The company potentially contributes to UN Sustainable Development Goal 4 "Quality Education".

Outlook

The geopolitical situation has become more tense since 2022, due to the events in Ukraine, continued tensions between the US and China, as well as the conflicts in the Middle East. The situation in Europe, in particular, still needs to be closely monitored, especially regarding energy security. As inflation growth rates have slowed worldwide, a further tightening of monetary policy at least seems unlikely. On the contrary, the major central banks already started cutting rates. Looking more specifically at the clean technology space, the backdrop over the past 6-12 months continued to be challenging, however, headwinds such as an unfavorable financing environment as well as overstocked supply chain are easing. Hence, we believe 2024 marked a transition year. That said, the next months will continue to be no less exciting, considering the outcome of the US presidential elections, and its potential impacts on economic and foreign policy, which still should be digested over the next couple of months. Beyond these near-term uncertainties, the ongoing policy support and technological progress across the globe should drive increased competitiveness across clean technologies and spur a significant step-up of clean tech investments in the 2020-2030 period and thereafter, as highlighted by the IEA's World Energy Outlook released at the end of October 2024. The risk premium for stocks in the sustainability space is currently quite elevated due to the significant uncertainty surrounding sustainability-related policies. However, we anticipate greater clarity in the coming months, particularly following the elections in Germany and the unveiling of detailed plans by the new US president on issues such as energy, education, and healthcare. This should improve visibility for investors, likely reducing the risk premium. We remain optimistic about the outlook given the risk-return profile of several stocks with revenues exposed to the different UN Sustainable Development Goals (SDGs).

Alpha

A measure of the difference between the risk-adjusted return on an investment and a benchmark. The alpha measures the part of the performance that cannot be explained by market movements or market risk, but rather is derived from the selection of securities within the market. Alpha is a way of measuring the active contribution to performance made by the portfolio manager. It is also a good yardstick to use when comparing several funds. The figure is calculated on a 3-yearly basis.

Average dividend yield

Measures the average dividend amount, based on the current share price. This figure is calculated based on the shares (including ADRs/GDRs - > Depositary receipts) and REITs contained in a fund.

Average market capitalization

Measures the average market capitalization of the shares, REITs and ADRs/GDRs (depository receipts) contained in a fund. The market capitalization represents the total market value of a company as determined by multiplying the number of shares issued by the current share price.

Beta factor

A measure of sensitivity - given as the average percentage change in the price of a fund when the market (benchmark) rises or falls by 1%. A value over (under) 1 means that on average the fund exhibits more (less) volatility than the benchmark. The figure is calculated on a 3-yearly basis.

Correlation coefficient

Describes the degree to which two values (fund versus benchmark) move in the same direction. The value of the correlation coefficient is between -1 and +1. A correlation of +1 means that the fund generally moves in the same direction as the benchmark, while -1 indicates that the fund generally moves in the opposite direction. A correlation of 0 means that there is no relation between the price movements of the fund and the benchmark. The figure is calculated on a 3-yearly basis.

Coupon

The coupon is the portfolio's average weighted coupon.

Duration (in years/in months)

A measure of the sensitivity of an investment to changes in interest rates. Duration, which was developed by Frederick Macaulay, is the average period for which invested capital is committed. Because of the interest payable over time on the invested capital, duration is shorter than -> maturity. This version of duration is used in DWS Top Reporting and refers to invested assets (without "Cash and other holdings").

Information ratio

The information ratio measures the difference between the annualized average return of the fund and that of the benchmark, divided by the Tracking error. The higher this value is, the more the investor compensated for the risk in the fund. The figure is calculated on a 3-yearly basis.

Maximum drawdown

The maximum drawdown is the largest percentage drop in value in a given period of time. It measures the amount the fund falls from its highest point to its lowest point in the selected timeframe. The figure is calculated on a 3-yearly basis.

Modified duration (in years/in months)

Serves as a measure of interest-rate sensitivity. Modified duration indicates the percentage change in price of a bond (in a portfolio) when the market interest rate changes by 1%. In order to calculate the percentage change in the bond price, the modified duration of the bond is multiplied by the percentage change in the interest rate. This figure helps investors assess the risks and opportunities of a bond at a glance.

Sharpe ratio

A measure of risk developed by William F. Sharpe, defined as the excess return on an investment over that of a risk-free investment in relation to the risk of the investment. The higher the Sharpe ratio, the higher the return the investor receives for the risk the investment carries (expressed in volatility). The Sharpe ratio can be used to compare multiple funds. The figure is calculated on a 3-yearly basis.

Tracking error

The tracking error is the standard deviation of the yield differential between a fund and its benchmark. This makes it a measure of how well the fund manager tracks the benchmark. The figure is calculated on a 3-yearly basis.

VaR (Value at Risk)

A measure of risk that indicates the maximum fund losses with a given probability for a given period of time (holding period). VaR is calculated on the basis of the daily prices of the individual securities contained in the portfolio for a year.

Weighted Average Life

The weighted average life of the times of the principal repayments of a liability, i.e. a bond. Refers to invested fund assets (without "Cash and other holdings").

Yield

The yield is the annual return on a capital investment, measured as the actual interest earned (effective yield) on the capital invested. It is based on the fund's income (e.g., interest, dividends, realized capital gains) and change in the price of the assets held in the fund. The yield of a fund is

derived from the invested assets (without "Cash and other holdings") and is presented as a "gross" figure, i.e., before the deduction of total expenses/fee.

Volatility
Volatility expresses the degree to which the yield on an investment (the price performance of a fund, for example) varies from a mean value in a specific period of time. This makes it a measure of fund risk. The greater the variation from the mean, the higher the volatility. Knowing the volatility allows investors to assess how uncertain the return potential of an investment is. The figure is calculated on a 3-yearly basis.
