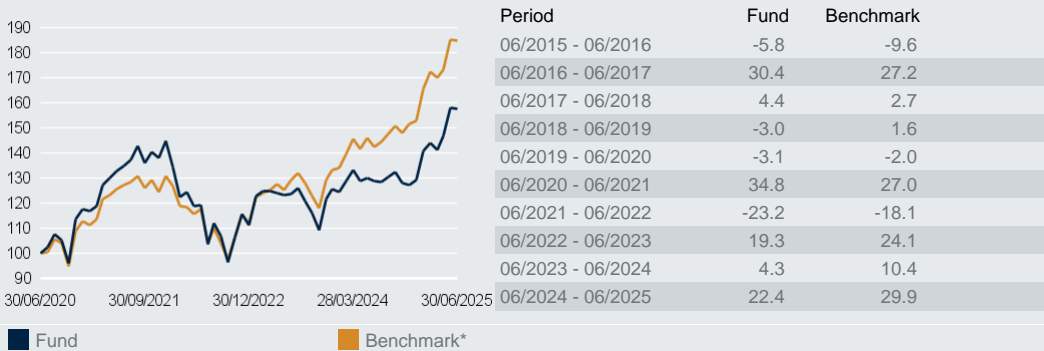

Performance Review

In June, European equity markets recorded a modest decline, ending the month down 1.3%. While in previous months, U.S. politics continued to set the tone for global markets, headlines in June surrounding negotiations with the EU and China proved to be merely temporary disruptions. Rising geopolitical tensions in the Middle East, particularly the Iran-Israel conflict, also had only a short-lived impact on financial markets. This allowed global equities, and U.S. stocks in particular, to extend their gains. Ahead of the upcoming Q2 earnings season, economic data releases were mixed in both the U.S. and Europe. The technology sector once again supported market sentiment, rising by 1.3% over the month. In contrast, healthcare stocks came under pressure. After a turbulent quarter, many asset classes have made a full round trip since February. With the bombing of Iran by Israel and the U.S., an already turbulent second quarter came to an end.

German equities remained in focus, driven by greater confidence about the prospects in Germany. The new German government's fiscal package has contributed to this. Investors are increasingly hopeful that a pro-growth policy could improve the region's long-term growth perspectives. The €500bn infrastructure package, combined with off-budget defence spending, could be supportive. The German purchasing managers' index for the manufacturing sector rose to 49.0 (previous month: 48.3). The IFO index increased to 88.4 (previous month: 87.5). The combination of cyclical recovery, supportive policy dynamics, and structural investment drivers could create attractive perspectives for the German Equity market.

Performance Attribution

DWS Aktien Strategie Deutschland ended the month of June 2025 nearly flattish in line with its benchmark the HDAX UCITS Capped index. Positive contributors to the fund's performance versus its benchmark were the fund's overweight position in Siemens Energy and Airbus, which both performed well. The slight overweight of the Materials sector also supported the performance of the fund. Auto1's shares rose and supported the fund's performance after delivering strong quarterly numbers. Shares of Symrise and Zalando contributed negatively to the performance of the fund. We decided to trim our position in Allianz, Munich Re, Deutsche Telekom, Generali and some small cap positions in the fund to adapt to recent market developments. We have initiated a new position in Fielmann, easyJet and others as part of our portfolio. Additionally, we increased our weights in Airbus and Deutsche Bank.

Current Positioning

We maintain our main overweight positions in Industrials, IT and Health Care as well as remain underweight in Consumer Discretionary, Communication and Financials.

Outlook

We are sticking to our constructive outlook in the core scenario now although the target returns have been reduced slightly after the strong market performance in recent weeks. Provided there are no further negative surprises we believe one could argue for the positive market momentum to continue. Then again, risk premiums on both the equity and corporate bond markets have already shrunk so much that even minor disappointments could be enough to trigger another correction. Any renewed tariff alarms going forward, could cause fresh volatility on the markets.

Alpha

A measure of the difference between the risk-adjusted return on an investment and a benchmark. The alpha measures the part of the performance that cannot be explained by market movements or market risk, but rather is derived from the selection of securities within the market. Alpha is a way of measuring the active contribution to performance made by the portfolio manager. It is also a good yardstick to use when comparing several funds. The figure is calculated on a 3-yearly basis.

Average dividend yield

Measures the average dividend amount, based on the current share price. This figure is calculated based on the shares (including ADRs/GDRs - > Depositary receipts) and REITs contained in a fund.

Average market capitalization

Measures the average market capitalization of the shares, REITs and ADRs/GDRs (depositary receipts) contained in a fund. The market capitalization represents the total market value of a company as determined by multiplying the number of shares issued by the current share price.

Beta factor

A measure of sensitivity - given as the average percentage change in the price of a fund when the market (benchmark) rises or falls by 1%. A value over (under) 1 means that on average the fund exhibits more (less) volatility than the benchmark. The figure is calculated on a 3-yearly basis.

Correlation coefficient

Describes the degree to which two values (fund versus benchmark) move in the same direction. The value of the correlation coefficient is between -1 and +1. A correlation of +1 means that the fund generally moves in the same direction as the benchmark, while -1 indicates that the fund generally moves in the opposite direction. A correlation of 0 means that there is no relation between the price movements of the fund and the benchmark. The figure is calculated on a 3-yearly basis.

Coupon

The coupon is the portfolio's average weighted coupon.

Duration (in years/in months)

A measure of the sensitivity of an investment to changes in interest rates. Duration, which was developed by Frederick Macaulay, is the average period for which invested capital is committed. Because of the interest payable over time on the invested capital, duration is shorter than -> maturity. This version of duration is used in DWS Top Reporting and refers to invested assets (without "Cash and other holdings").

Information ratio

The information ratio measures the difference between the annualized average return of the fund and that of the benchmark, divided by the Tracking error. The higher this value is, the more the investor compensated for the risk in the fund. The figure is calculated on a 3-yearly basis.

Maximum drawdown

The maximum drawdown is the largest percentage drop in value in a given period of time. It measures the amount the fund falls from its highest point to its lowest point in the selected timeframe. The figure is calculated on a 3-yearly basis.

Modified duration (in years/in months)

Serves as a measure of interest-rate sensitivity. Modified duration indicates the percentage change in price of a bond (in a portfolio) when the market interest rate changes by 1%. In order to calculate the percentage change in the bond price, the modified duration of the bond is multiplied by the percentage change in the interest rate. This figure helps investors assess the risks and opportunities of a bond at a glance.

Sharpe ratio

A measure of risk developed by William F. Sharpe, defined as the excess return on an investment over that of a risk-free investment in relation to the risk of the investment. The higher the Sharpe ratio, the higher the return the investor receives for the risk the investment carries (expressed in volatility). The Sharpe ratio can be used to compare multiple funds. The figure is calculated on a 3-yearly basis.

Tracking error

The tracking error is the standard deviation of the yield differential between a fund and its benchmark. This makes it a measure of how well the fund manager tracks the benchmark. The figure is calculated on a 3-yearly basis.

VaR (Value at Risk)

A measure of risk that indicates the maximum fund losses with a given probability for a given period of time (holding period). VaR is calculated on the basis of the daily prices of the individual securities contained in the portfolio for a year.

Weighted Average Life

The weighted average life of the times of the principal repayments of a liability, i.e. a bond. Refers to invested fund assets (without "Cash and other holdings").

Yield

The yield is the annual return on a capital investment, measured as the actual interest earned (effective yield) on the capital invested. It is based on the fund's income (e.g., interest, dividends, realized capital gains) and change in the price of the assets held in the fund. The yield of a fund is

derived from the invested assets (without "Cash and other holdings") and is presented as a "gross" figure, i.e., before the deduction of total expenses/fee.

Volatility

Volatility expresses the degree to which the yield on an investment (the price performance of a fund, for example) varies from a mean value in a specific period of time. This makes it a measure of fund risk. The greater the variation from the mean, the higher the volatility. Knowing the volatility allows investors to assess how uncertain the return potential of an investment is. The figure is calculated on a 3-yearly basis.
