alongside the financial performance. In this context, the selection of individual investments is the responsibility of the fund management. The currency of the fund is USD. The fund distributes annually. You may request the redemption of shares generally on a daily basis. The Company may, however, suspend or restrict the redemption if extraordinary circumstances appear to make this necessary, taking into account the interests of the investors.
