What is this product?

Type

The product is a UCITS - Part 1 FCP under Luxembourg law.

Term

This product has a maturity until 06.12.2027. You may request the redemption of shares generally on each valuation date. The company may, however, suspend the redemption if extraordinary circumstances appear to make this necessary, taking into account the interests of the investors. Further, the company may restrict the redemption. The product may be redeemed early in certain circumstances as set out in the sales prospectus. The LD share class of DWS Laufzeit Unternehmensanleihen Plus 2027 was launched in 2023.

Objectives

The fund is actively managed. The fund is not managed in reference to a benchmark. The objective of the investment policy is to pay out annual distributions of income and to preserve the capital invested until the fund's maturity date in 2027 (no guarantee). To attain this objective, the fund invests in corporate bonds denominated in euro or hedged against the euro. At least 30% of the securities acquired have an investment-grade rating, and up to 70% may have a high-yield rating. The fund employs derivatives for hedging and investment purposes. (A derivative is a financial instrument whose value depends on the performance of one or more underlying assets.) The residual maturity of the securities in the fund is based on the maturity date of the fund. The selection of the individual investments is at the discretion of the fund management. The product's income is reflected in the net asset value per share that is calculated daily and, if relevant, in the distribution amount. The currency of the fund is EUR. The fund distributes annually. This fund is a sub-fund of DWS Laufzeit for which the sales prospectus and the periodic reports are prepared as a whole. The assets and liabilities of each sub-fund are segregated by law. As a result, assets of one sub-fund are not available in the event of claims against or insolvency of another. More share classes may be available for this fund - please refer to the relevant section of the sales prospectus for further details. In many cases, the shares may be replaced by shares in a different share class of the same sub-fund or of another DWS Laufzeit sub-fund. Further information can be found in the section "Exchange of shares" in the Sales Prospectus. The depositary is State Street Bank International GmbH, Luxembourg Branch. Intended retail investor

The sub-fund is intended for private investors with a medium-term focus who have basic knowledge/experience and who can bear losses. The sub-fund may be used for general accumulation of capital. The fund is not suitable for investors who would like to withdraw their capital from the fund before December 6, 2027.

What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the capacity to pay you.

What happens if DWS Investment S.A. is unable to pay out?

The assets of the fund are kept separately from those of the management company, DWS Investment S.A.. An insolvency or default of the management company should not result in the fund suffering any financial loss in relation to its assets. On the insolvency or default of the depositary State Street Bank International GmbH, Luxembourg Branch securities held by the depositary on behalf of the fund should be protected but the fund may suffer loss in relation to cash and certain other assets which are not protected. Cash deposits of the fund deposited with other credit institutions may cause investors to suffer a financial loss if such deposits are not covered by any existing deposit guarantee schemes. Investment in the fund is not covered by any investor compensation or guarantee scheme.

What are the costs?

How long should I hold it and can I take money out early?

Recommended holding period: 2.85 years. The product has a fixed maturity date as of 06.12.2027.

This product has no required minimum holding period. The recommended holding period has been selected due to its investment strategy and because it is designed for a short term investment horizon. It is expected that it will be possible to achieve the investment objective of the fund within this time frame. You may request the redemption of shares generally on each valuation date. Please refer to 'Composition of costs' table above for more information on costs when cashing in before the end of the recommended holding period.

There is no change on the risk return profile when you redeem your shares early.
